Dear Monique,

I would like to ask you to share following statement with upcoming general assembly participants.

Statement of the Czech Society of Actuaries (ČSpA)

Dear Members of the General Assembly,

The Czech Society of Actuaries recognizes the Actuarial Association of Europe as a platform intended to serve the European actuarial profession in its full geographical and professional diversity.

In our view, the current difficulties do not primarily arise from membership status or procedural arrangements, but from a growing misalignment between the strategic objectives of the AAE and the strategic interests of the Institute and Faculty of Actuaries. This misalignment has direct implications for the perceived value of membership and, consequently, for the willingness to contribute financially.

For this reason, ČSpA is unable to support the proposed voting statements as presented. They risk addressing symptoms rather than the underlying cause and, by doing so, may foreclose legitimate strategic options.

We believe the AAE now needs to return to a strategic discussion. Either the AAE should identify and pursue strategic objectives that are genuinely relevant also for non-EU member associations such as the IFoA, thereby sustaining their commitment and contributions; or, alternatively, financial contributions should be structured in a way that more explicitly reflects activities primarily related to cooperation with EU institutions.

In this context, ČSpA strongly supports an open, good-faith dialogue with a sufficiently broad mandate, aimed at restoring strategic coherence, institutional stability and long-term mutual benefit.
