The Colloquium is not a meeting of official representatives of the National Associations of Actuaries by which it is convened. No resolution will be passed. Opinions expressed in the Colloquium documents and during the discussions are exclusively those of their authors.

Colloquium documents are not Groupe Consultatif documents; they are not intended for presentation to Government or European Union authorities.

The Groupe Consultatif's Colloquium will be held this year in München at the invitation of the Deutsche Aktuarvereinigung – the German Actuarial Society.

The theme of the Colloquium, **Long-Term Care for the Suffering Insurance Industry: an Actuarial Challenge**, is at the moment one of the most important and current topics for the actuarial community. It includes key questions such as "Is the Insurance Business Model suffering?" or "Is Basel II a contradiction to the Business Model of Insurance?"

On behalf of the German Actuarial Society, may we welcome you to what we hope will be a most stimulating event in the fascinating city of Munich.

City Tour of München

More a kind of adventure tour than a classic sightseeing tour, exploring the city partly on foot and partly by bus, participants will visit the famous "Nymphenburg Castle", the royal summer residence of kings and queens. This will be followed by a visit to the "Olympiapark" - the largest event and leisure centre of Europe, with a climb to the top of the 300 metre high "Olympiaturm" for the most energetic!

On returning to the city centre, the bus will pass "Siegestor", the former artist colony of "Schwabing", the "Königsplatz", the "Feldherrenhalle" and the "Friedensengel".

After lunch there will be a visit on foot through the beautiful old town of München. Continuing from a short refreshment break, the walk will take participants through the southern part of the "Englischen Garten" and the "Hofgarten", finally returning to the old town with such sights as the "Platzlgassen", the "Alte Hof", Mozart's former residence, the city hall before returning to their hotel.
