



## Webinar on the AAE Code of Professional Conduct 9 October 2018 | 10.00-12.00 CEST

#### **PURPOSE**

AAE Full Member Associations (FMAs) must have a Code of Conduct in place that reflects at least the requirements of the AAE's Code of Professional Conduct (*AAE Statutes, Article 5*). A new **AAE Code of Professional Conduct** (CoPC) has been published and each FMA must ensure that its Code of Conduct reflects the new CoPC by 1 January 2021.

The AAE CoPC does not apply directly to individual actuaries. However, fully qualified actuaries (and, in some instances, other members of FMAs) must comply with their association's Code of Conduct, which will reflect at least the requirements of the CoPC.

This webinar will be useful for:

- Anyone who is involved in a Full Member Association's work on reviewing and (if necessary) updating its Code of Conduct;
- Individual actuaries who would like to improve their understanding of the principles of professionalism that are addressed in Codes of Conduct.
