## Invitation to Actuarial Courses at Salzburg University

The newly established *Salzburg Institute of Actuarial Studies* offers international actuarial courses starting with the winter semester 2005/2006. These courses address persons who have completed mathematical studies at university (or an equivalent institution) and intend to become actuaries. The courses are taught in English.

## Eight courses, namely

- Life Insurance Mathematics
- Health Insurance Mathematics
- Mathematics of Pension Plans
- Statistical Methods in Insurance, Part A
- Statistical Methods in Insurance, Part B
- Non-Life Insurance Mathematics
- Mathematics of Finance
- Actuarial Modelling

comprise all the actuarial topics that are required to become a fully qualified actuary

- according to the core syllabus of the International Actuarial Association and the core syllabus of Groupe Consultatif
- according to the regulations of the Actuarial Association of Austria (AVÖ)
- according to the regulations of the German Actuarial Association (DAV).

The German regulations have just been revised; all courses are in full accordance with the new German requirements.

Each course may be attended separately, and each course can be completed with a separate exam. The courses are open to everybody. In particular, the course on statistical methods in insurance is also of interest to experienced practitioners.

During the next four semesters the courses will take place in the following order:

Winter semester 2005/2006: Statistical Methods in Insurance, Part A

Life Insurance Mathematics

Summer semester 2006: Statistical Methods in Insurance, Part B

**Health Insurance Mathematics** 

Winter semester 2006/2007: Mathematics of Finance

Non-Life Insurance Mathematics

Summer semester 2007: Mathematics of Pension Plans
